

*Improvement of energy efficiency of budgetary institutions in the city of Irpin*

**INVITATION FOR TENDERS**

***Insulation of walls, replacement of windows and doors, reconstruction of ventilation system, modernization of internal lighting in school №3; insulation of walls, replacement of windows and doors, attic insulation, modernization of internal lighting, reconstruction of ventilation system and heat pump for tap water in Pre-school No. 6***

Department of Education and Science of the Irpin City Council hereinafter referred to as “the Employer”, intends to use part of the proceeds of a loan from the Nordic Environment Finance Corporation (NEFCO) towards the cost **for** ***Insulation of walls, replacement of windows and doors, reconstruction of ventilation system, modernization of internal lighting in school №3; insulation of walls, replacement of windows and doors, attic insulation, modernization of internal lighting, reconstruction of ventilation system and heat pump for tap water in Pre-school No. 6.***

The Employer now invites tenders from Contractors for the following contract to be funded from part of the proceeds of the loan:

**- supply and installation of materials for school №3:**

- Insulation of walls – 4,836.87 m<sup>2</sup>;
- Insulation of the passage ceiling – 341.13 m<sup>2</sup>
- Replacement of windows (430.24 m<sup>2</sup>) and external doors (54.66m<sup>2</sup>) on energy efficiency;
- Installation of decentralized ventilation system with heat recovery- 56 units;
- Replacement of incandescent lamps with LED lights - 1600 units.

**- supply and installation of materials for Pre-school №6:**

- Insulation of walls – 1,851 m<sup>2</sup>;
- Restoration of blind area – 280 m<sup>2</sup>
- Attic insulation – 1077 m<sup>2</sup>
- Replacement of windows (3.51 m<sup>2</sup>) and external doors (31.32m<sup>2</sup>) on energy efficiency;
- Installation of decentralized ventilation system with heat recovery – 24 units;
- Installation of heat pump for tap water;
- Replacement of incandescent lamps with LED lights - 330 units;

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- the Tenderer, has the financial, technical and production capability and capacity necessary to perform the Contract, and Tenderer’s average annual revenue in the previous **three** years was at least **two** times greater than price of his tender. In case of tender submitted by JVCA, the leading partner should demonstrate at least 50% compliance with the requirement;
- the Tenderer has satisfactorily supplied similar plant and works to other purchasers and completed at least **five (5)** similar contracts in the recent **five** years
- the Tenderer or its agent will be able to carry out warranty obligations;
- the Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;
- in the case of a Tenderer offering to supply plant under the Contract which the Tenderer does not manufacture or otherwise produce, the Tenderer has been duly authorised by the plant’s manufacturer or producer to supply the plants in the Purchaser’s country.

Tender documents, upon request from prospective tenderer, will be sent by email free of charge in electronic format (PDF file). If requested, the documents will be sent by Employer to Tenderer on terms and conditions agreed by the two.

Tenders must be delivered to the office at the address below on or before 10.00 am, 26.10.2017, at which time they will be opened in the presence of those tenderers’ representatives who choose to attend.

Meeting of the Tenderers with representatives of the Employer with the purpose to visit project objects will take place at 10 am, 26.09.17 at Irpin, Shevchenka str., 2a, office 17.
